My take on it, by Estella Lauter:

What do Americans Mean by "Freedom"?

Is there anyone among us during this holiday season who has not been distressed by news of the so-called "fiscal cliff" on which the majority of our Representatives have apparently set up camp, and the farfetched ideas about

gun control in the wake of the tragic deaths in Newtown, CT? Can anyone see a way to get us on the same page long enough for a reasonable discussion of either issue to take place?

I have no crystal ball, but as the opinions have swirled around the air waves with increasing speed, I have begun to see at least one way that the two issues (how to limit the federal debt in the next decade and how to prevent killing sprees) are connected. They both depend on the way one interprets the idea of freedom. I doubt that we will reach satisfactory resolutions of these issues until we address our more basic disagreements about the idea of freedom.

During the Bush II era, it was fine to run up the national debt for two unbudgeted wars and Homeland Security, the most extensive federal agency in U.S. history, while giving tax breaks to the super rich. This appeared to result from a belief in the freedom of individuals to earn as much money as possible without a concomitant responsibility to support the system that made their wealth possible—at least this is the only way I can make sense of the historical facts.

Likewise, gun control became an issue of individual freedom instead of public safety when the NRA underwent an internal revolution in the Seventies!

The idea of freedom that proponents of fiscal austerity and the right to bear arms for self-defense share has been called "negative freedom" by philosophers. When it is stated philosophically, as "freedom from unreasonable external constraints on action" (entry for political freedom, www.Wikipedia.com), it sounds fine. But everything depends on the interpretation of what is "unreasonable."

In the last decade, Republicans have typically argued that taxes are an unreasonable external constraint on both individuals and corporations, while Democrats (at least in WI) have argued that taxes are an investment in and the price of a civil

society, and that those who make more money must pay their fair share.

On the issue of gun control, Republicans have introduced "concealed carry" laws in every state and have refused any restrictions on ownership except in cases where the proposed owner has a criminal record or a known mental illness. Democrats, on the other hand, have found the Brady ban on automatic weapons highly reasonable, and we have argued for more complete background checks by gun dealers regardless of the venue for sales (gun shows should not be exempt from these rules). We would probably accept the principle that operates in the UK, whereby one can carry a gun (or a knife) only if there is a good reason to do so and only with a certificate.

On both issues (taxation and gun control), Dems have many other successful developed countries on our side, and our own history supports both increased taxes on the wealthy and rules (such as licensing for drivers and hours for selling liquor) to ensure public safety.

Our Constitution gives Congress the authority to raise the money and to make regulations necessary to ensure that citizens are able to pursue the ideals of "life, liberty and the pursuit of happiness" for which the Republic was founded. Liberty in that context meant political and religious liberty from oppression rather than an individual's right to do or have whatever he wants; although the Founders privileged white men who owned land, they were also profoundly concerned with political unity or polity.

However, This authority is based on another idea of freedom that also comes into play in taxation and gun control. Philosophers call it a "positive" concept of freedom" that enables an individual or group to realize its potential or exercise its rights, capabilities and possibilities for action. It has evolved to mean "freedom from want"—from poverty, starvation, treatable disease, oppression, force and coercion (Wikipedia, as above).

This interpretation makes it impossible for most Democrats even to consider the possibility of a country that does not provide public access to education or that makes people dependent on the unpredictable generosity of donors for their daily bread or shelter. One prominent philosopher, Alasdair MacIntyre, understands freedom primarily in terms of social interdependence.

There is something wrong with this picture. It is the absence of any sense of responsibility toward others-- toward a community, a public, that consists of people who are not exactly like one in their backgrounds, values, color, class, and so on. In the absence of this most basic societal value, neither a negative nor a positive construction of freedom makes sense.

Another philosopher, Nikolas Kompridis, contrasts two ideals of freedom: the first stresses autonomy and independence; the second posits the ability to initiate a new beginning, cooperatively. Amartya Sen has developed the second ideal in an economic theory that works to create a larger set of choices for everyone.

As I have listened to the arguments about the fiscal cliff and gun control this holiday season, I

have found the famed American commitment to autonomy less and less attractive.

In relation to these issues and many others, we need to insist on the freedom to initiate a new beginning, a more cooperative discussion, based on a clearer understanding of potentially shared values such as freedom instead of on unexamined slogans.

The House has the capacity to dump the ill-considered agreement that was made when the debt ceiling was raised last year. The NRA has a history of concern for public safety to balance its obsession with ideology of an individual's right to bear arms. Let's encourage our government and other institutions to start over again on these issues in the new year. As Socrates said, "the unexamined life is not worth living."
